<u>COURSE DESCRIPTION</u>: This course covers characteristics of real estate investments. It includes techniques of investment analysis, time-valued money discounted and non-discounted investment criteria, leverage, tax shelters, depreciation and application to property tax.

<u>COURSE OBJECTIVES</u>: The student will compute financial projections using cash flow analysis and internal rates of return and estimate appreciation; determine the advantages and disadvantages of commercial investments; and utilize the different tax rates in calculating ad valorem.

<u>TEXTBOOKS AND MATERIALS</u>: Students will need a copy of Essentials of Real Estate Investment, 12th Edition. ISBN: 9781475485400. Please verify the book purchased is the correct edition. A financial calculator is needed for this class.
